A.) the 28" diameter red oak leaning away from the rock ledge over the utility wires and Central Ave to the right of the gate entrance		
B.) the 26" diameter 80% dead red oak with decay fungus showing on the main trunk behind A above		
C.) the 30" diameter 60% dead Norway maple being killed by its own girdling on the sidewalk strip, 200' down Columbine Rd against the wall

Prune the large double-trunk 36" diameter red oak 80' down on the right side of the Columbine Rd by: (A) removing the 8", 10", 12", and 6" diameter limbs on the north side of the trunk to allow more room for a new building, (B) removing deadwood throughout the remainder of the crown.
